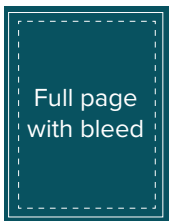

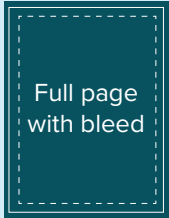

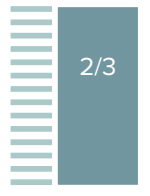

instigate 2027 ADVERTISING PLACEMENT GUIDELINES

In the interest of fairness to all Instigate advertisers, we have established the following guidelines for special advertising placement. This includes advertisements placed on the back cover, inside front cover, inside back cover, and across from the table of contents.

2027 Issue	Reservations Deadline	Materials Deadline
January/February	October 12, 2026	November 9, 2026
March/April	December 7, 2026	January 4, 2027
May/June	February 8, 2027	March 8, 2027
July/August	April 5, 2027	May 3, 2027
September/October	May 31, 2027	June 28, 2027
November/December	August 2, 2027	August 30, 2027

1. Advertisers must notify Citygate Network of their interest in special placement in Instigate by completing and submitting the ad placement order form (page 4) by October 12, 2026.
2. Previous ad placement doesn't affect the upcoming year placements.
3. Uncontested placements are granted on the business day following the reservations deadline (October 12, 2026). Placements with multiple interested parties are decided by a drawing.
4. The Ad Placement Drawing (if needed) proceeds as follows: outside back cover, inside front cover, inside back cover, and opposite of the table of contents. Drawing to be held October 13, 2026.
5. Advertisers can indicate interest in multiple placements. If a business gets a placement, it's removed from other level drawings unless there's no other interested party.
6. Advertisers will be notified of the placement drawing results on October 13, 2026.
7. Citygate Network business members will be given priority. If a business member and a non-business member are both interested in the same placement, the business member is awarded that placement without a drawing. Non-business members are awarded a preferred placement only if they are the sole interested party or if only other non-business members are interested. If multiple business members or non-business members want the same placement, a drawing is held.
8. Citygate Network automatically enters advertisers not awarded their desired placement into the drawing for the next available placement unless the business requests otherwise.
9. Uncontested remaining placements will be awarded on a first come, first served basis after the ad placement drawing.
